Changes to WGC Membership Levels & Renewal Deadline

On February 6th, we held a general membership meeting to discuss changes to the membership levels of the WGC. In response to comments from many members and prospective members that the membership structure was not aligned with their budgetary constraints, we are excited to announce that the membership approved the following revisions to our membership levels:

- Two new membership levels for members under 30 years and over 70 years of age with lower donation levels of \$150 and \$250, respectively
- Names for each membership level
- Extending the age limit for Next Generation membership (now called Connect) to 40 years of age

These changes make membership more inclusive and affordable for those at the lower and higher ends of the age spectrum, thus enabling more members to join early in life and continue their membership into their later years. This does not preclude a member from continuing with her existing donation amount even if her age allows for a donation of less than \$550. An administrative fee of \$50 will be assessed for each level regardless of the amount of donation provided by the member.

In addition, the membership renewal deadline has been changed from December 15 to December 1st, which allows us to close out the membership drive by the beginning of January, so please keep this is mind when planning for your renewal.
